What is CMO?

CMO is an acronym for **Cetyl Myristoleate**. Discovered by the late Dr. Diehl in the mid 1990's, this natural product has been shown to repair the joint connective tissue in both animals and humans.

What is CMO-ReVive?

This natural blend affects joint relief by helping to re-build the joint's connective tissue. Universal Formulas' CMO-ReVive is the highest potency product on the market of its kind. Dr. Diehl found that between 55-60 grams of elemental CMO suffices in the average person to begin to repair the connective tissue of affected joints. Three containers of our CMO-ReVive provide the loading dose that most people need in order to feel a difference...Universal Formulas' CMO-ReVive is an enhanced blend with the addition of specific enzymes and 77 Fulvic trace minerals.

This bio-engineered blend is the only one of its kind to incorporate high potency CMO (20% elemental value), Enzymes, Vitamins and Fulvic Trace Minerals altogether. CMO ReVive provides simplified, consistent and effective supplementation. More detailed ingredients and properties are as follows:

- **CMO-20% Complex:** the highest potency CMO to date. Provides joint/connective tissue repair.
- **Lipase Enzymes** that aid in the breakdown of CMO, making CMO deliverable at a cellular level.
- **MSM & Glucosamine** for pain relief and inflammation control.
- **Specific Minerals** are the building blocks for healthy bones, muscles and tendons.
- **77 Trace Fulvic Minerals** provide the precious electrical charge needed by each cell.
- **Specific Vitamins** help the body to utilize critical nutrients.

An Exclusive Blend from the Owner of Universal Formulas

Known for his perfectionist tendencies, it is not surprising that the owner of Universal Formulas set about the task of analyzing the best CMO products on the market and ways in which these could be improved. With his desire to create "the best of the best," he developed a blend with the following primary criteria:

- ✓ **Highest Quality** (only the best available ingredients used);
- ✓ **Highest Potency** (CMO, providing enough CMO to be delivered to the joint);
- ✓ **Enzyme Enhancement** (to break down CMO, a fatty acid, for better delivery);
- ✓ **Mineral Enhancement** (to provide fundamentals for healthy bones, muscles and tendons);
- ✓ **Inflammation Relief** (for immediate joint relief, to allow healing to occur).

Please Note: CMO-ReVive contains high amounts of MSM and Glucosamine. Anecdotal evidence indicates that Glucosamine and MSM assist patients' suffering from Arthritis by providing temporary relief. We do not add Chondroitin because our bodies naturally turn Glucosamine into Chondroitin, whereas direct Chondroitin supplementation is poorly absorbed in the body (by a percentage of 10 or 20). Glucosamine absorption levels exceed 90%. By providing more Glucosamine instead of adding Chondroitin, our blend enables the body to actually gain more Chondroitin through this efficient conversion/absorption dynamic.

What is the recommended dosage for CMO-ReVive?

We recommend twelve capsules daily as follows:

Four capsules three times daily, preferably 30-45 minutes prior to meals, or, at bedtime.

How long do I take CMO-ReVive?

A ninety-day regimen is typical. Each of our CMO-ReVive capsules delivers 55 mg of elemental CMO. Therefore, three containers of 360 capsules (totaling 1080 capsules) deliver 59.4 grams of elemental CMO. Anecdotal data suggests that the body requires 55-60 grams of elemental CMO to provide long-term joint relief. Three containers, then, are a typically sufficient "loading factor." Many people find benefit in a small dosage thereafter, as a maintenance program, which is one capsule daily, or, can be condensed into a weekly dosage of seven capsules. Others choose to 're-load' their bodies with another complete 90-day regimen after a year or two of taking anywhere from zero capsules to one capsule per day.

Other Information About Dosage:

- ✓ Some individuals, while on the CMO regimen, may benefit from taking one 400-unit capsule of natural, unesterified Vitamin E (*Item #5071*) each morning at breakfast. As an antioxidant, Vitamin E works synergistically with fatty acid supplements such as CMO.
- ✓ Anecdotal data also indicates that every body processes CMO differently. Some bodies may require more or less CMO for the desired effect. Body mass and the degree of damage in the body play a role in the amount of CMO required. Some people do not benefit from taking CMO.
- ✓ As with any supplement, achieving the best results may require a change in lifestyle. Keeping an extremely healthy diet, exercising the body and mind, limiting alcohol and caffeine intake, avoiding cigarette smoke and taking supplements are just a few ways to improve overall health.
